Product Details

Experian Social Security Search: Information provided by Experian and the Social Security Administration regarding the consumers: address history, AKA names and date of birth. This verifies the consumer's identity as well as provides important information for starting the background check.

Experian Employment Credit Report: Credit information provides insight into an applicant's responsibility towards their obligations. Information provided includes: consumer identification, employment information, public record information on bankruptcies, liens and judgments, overview of how financial obligations are handled.

Multi-State Criminal Record Search: Based on the address history provided on the Social Security Search each state the applicant has resided in is researched for criminal records. Additionally, in select states not all counties report to the state level, so in those states additional county level searches will be researched. County level searches may cause additional research fees.

National Sex Offender Search: Researches information on sex offenders who are required to register in their state.

State AKA's or Maiden Names Search: AKA names listed on the Social Security Search will be researched for criminal and sex offense records.

Education Verification: Verifies applicant's educations information. Includes: date degree awarded, title of degree, official name of school, major studied, dates of attendance.

Professional or Personal Reference: Phone calls made to Personal or Professional References regarding the applicant's character. A list of questions may be provided by the client on what is to be asked.

Global Security Watch List: Many national lists are searches such as: OIG, GSA, OFAC, etc. Full list of lists checked can be provided upon request.

Motor Vehicle Check: List of traffic and driving offenses against the applicant.

National Criminal Search: Instant search of various state and local criminal records databases. Nationwide in scope, it contains records from State Departments of Corrections (DOC) Administrative Office of the Courts (AOF), historical county court records, Department of Public Safety and Traffic Courts. It is to be noted that not all states and counties report all data to national databases.
